#### SAMPLE BEQUEST LANGUAGE

We have provided some basic bequest language to assist you and your attorney. If you have questions, need further information, or wish to establish an endowed fund through your legacy gift, please contact us so that we can support you in your planning.

- 1. Bequest of a specific dollar amount
- "I hereby, give, devise and bequeath [\$Dollars] to Wittenberg University, a nonprofit organization located at P.O. Box 720, Springfield, OH 45501-0720, Federal Tax ID: 31-0537177, for Wittenberg University's general use and purposes."
- 2. Beguest of percentage of an estate
- "I hereby, give, devise and bequeath [Percentage of Your Estate] to Wittenberg University, a nonprofit organization located at P.O. Box 720, Springfield, OH 45501-0720, Federal Tax ID: 31-0537177, for Wittenberg University's general use and purposes."

### **TYPES OF BEQUESTS**

A bequest may be made in several ways:

- Gift of a dollar amount
- Gift of a percentage of your estate
- Naming Wittenberg the beneficiary of a retirement asset like an IRA or 401(k)
- Gift of a specific asset
- Gift of the residue of your estate
